



TERMS AND CONDITIONS: COMPETITION WIN AN F1 DRIVING EXPERIENCE WITH FANTASTIC RACING.

TERMS AND CONDITIONS OF THE COMPETITION:

1. This competition is open to all persons aged 18, however you need to be over 25 and have held a valid driving license for over 3 years to drive the F1 car. The winner may transfer the prize of the F1 drive to any person of his or her choosing as long as that person is over 25.
2. By entering this competition the entrant will be deemed to have read and understood these rules and to be bound by them and by any other requirements set out in any related promotional material. The competition is governed by South African Law and any matters relating to the competition will be resolved under South African Law and the Courts of South Africa shall have exclusive jurisdiction.
3. To enter the competition at the airport, purchase a ticket from the stand. You have one in 300 chances to WIN a day driving the F1 car. Each ticket will be picked randomly from the ticket vouchers.
4. The winner will be notified at the email address or telephone number given in the contact details within 20 days of the closing date of the relevant competition.
5. The winner will be required to ring the promoter, Fantastic Racing (SA) (Pty) Ltd and experience the F1 Drive within 12 months of winning.
6. The timing of the F1 Driving Experience will depend on the availability of the F1 car but not be longer than 12 months from the date of the announcement of the winner of the competition.
7. The winner will be given three different dates when he/she has the opportunity to drive the F1 car. It is important to understand that the dates depend on availability of the race circuits, the car and Fantastic Racing's other events. Therefore, the date given to the winner will need to be set several months in advance.
8. The F1 drive, can be cancelled at last minute due to the rain or any other event beyond the control of the promoter. In the event of cancellation another day will be organised in the manner outlined above.
9. Acceptance of the prize by the winner gives the Promoter the right to use the prize-winner's name, personal photograph and home country for promotional purposes, both immediately after their win and in the future, unless prohibited by law.
